NOTICE INVITING TENDER

The Executive Officer, Sapatgram Municipal Board invites sealed Tender in the prescribed Form/ Document eventually to draw in Agreement Document of this Office, for the work mentioned below with validity period 6 (Six) months, affixing court fee stamp of ₹ 8.25 (*Rupees Eight and Paise twenty-five*) only from Contractors as shown below in respect of works. The tender will be received by the undersigned at his office up to **2:00 PM** on **04-09-2025** and will be opened on the same day and hour in presence of the intending bidders or their authorized agents. If the Office of the undersigned happens to be closed on date of receipts of tenders, the tenders will be received and opened in the same venue and time on the next working day. Earnest money as shown below in the form of NSC / KVP / Bank Guarantee / FDR / Bank Draft duly pledged to the *Executive Officer, Sapatgram Municipal Board* will have to deposit along with each tender. In case of bidder belonging to SC, ST, OBC or an unemployed. Graduate Engineer (Proof of the enclosed along with tender) the earnest money will be 50% of the value of earnest money to be deposited. The detailed tender papers may be obtained from the Office of the undersigned by the intending bidders on payment of ₹ 1000.00 (*Rupees One Thousand*) only in cash, which is non-refundable, during office hours from 10:30 AM to 3:00 PM working days up to **02-09-2025**.

The bidders have to quote item wise rate inclusive of GST and Labour Cess corrected to two digits after decimal point and no tender on percentage-based rate will be accepted. All contractors are to enclose PAN CARD, G.S.T Registration, Contractor Registration, Labour License, List of tools & plants, credentials of last three year of similar nature of work, Bank Guarantee Certificate, Self declaration of Key Person, Audited Balance Sheet, EPF Registration Certificate, ESIC Registration Certificate, etc.
