Notification

In pursuance of the directions issued by the Hon'ble Supreme Court in its order dated 11th August 2025 passed in Suo Moto Writ Petition (Civil) No (S).5 of 2025 in paragraphs 33(d), 33(e), 33(f), 33(h) and in view of the reports regarding untoward incidents caused by unregulated feeding of stray dogs as highlighted in the said order and, further, to ensure that the practice of feeding of dogs on roads and in public places is eliminated, as the said practice creates great difficulties for the common man walking on the streets, the following directions are hereby issued to be applicable within the municipal area:-

1. Feeding of stray dogs shall be allowed only in designated feeding spaces as listed below:

SI No	Ward No	Designated Feeding Space
1	1 & 2	Near Sapatgram Municipal Board (Katchary Field)
2	3 & 4	Near Maa Sarada Field
3	5 & 6	Near Ideal Club
4	7 & 8	Near Sevak Samity
5	9 & 10	Near APDCL

- 2. Under no circumstances feeding of stray dogs on the streets shall be permitted. Any person found feeding stray dogs on the streets in contravention of these directions shall be liable to be proceeded against under the relevant legal framework.
- 3. Any person or organization found causing any hindrance or obstruction in the effective implementation of the present directions shall be liable to be prosecuted for obstructing the public servant acting in compliance with the aforesaid directions is obstructed.
- 4. A dedicated helpline number 8133965413 has been created for reporting incidents of violations of the above directions and on receipt of report/s of such violations, appropriate measures shall be taken against such violators

It is hereby ordered that the aforementioned directions shall come into force with effect from the date of issue of this notification
