Whereas, during field verification and revenue inspection conducted by Circle Officer, Narayanpur Revenue Circle, it has been found that you are in unauthorized occupation/encroachment over Government land covered by Dag No. 640 of Sakrahi Map, measuring 0B-02K-0Ls out of land measuring 2 Bighas situated at Ward No.5B, Narayanpur Town, Narayanpur Mouza, under Narayanpur Revenue Circle, which was allotted in favour of Narayanpur Municipal Board for construction of Water Supply Scheme as informed vide letter no. NC.13/2010-22/614 dated. 04/12/2024.

And whereas, the said occupation/construction/use of land has been found to be unauthorized and without any lawful settlement/allotment/permission or valid title from the competent authority, you have erected unauthorized residential house.

And whereas, as per the law governing public land and in compliance with the directions issued by the Hon'ble Supreme Court of India vide Writ Petition WP(C) Civil No. 295 of 2022 regarding demolition/eviction proceedings, no coercive action shall be undertaken without affording reasonable opportunity to the occupant by issuance of a prior show cause notice and personal hearing.

Now therefore, you are hereby called upon to SHOW CAUSE within 15 (fifteen) days from the date of receipt of this notice as to why:

1. You should not be declared an unauthorized occupant/encroacher over the aforesaid Government land.
2. The alleged unauthorized occupation/construction standing over Dag No. 640 should not be removed/evicted.
3. Appropriate eviction and demolition proceedings should not be initiated against you under the relevant provisions of law.

You are hereby directed to submit the following documents, if any, in support of your claim:

1. Jamabandi/Patta copy;
2. Registered Sale Deed;
3. Mutation order;
4. Revenue payment receipts (And not Encroachment Penalty Receipt)
5. Any Government allotment/settlement order;
6. Any order passed by competent Court/Authority;
7. Any other supporting document.

On the date of personal hearing in the matter which has been fixed on 10<sup>th</sup> June, 2026 at 11 AM in the office chamber of the undersigned where you may appear either personally or through an authorized representative along with relevant documents.

Please note:

If no reply is received within the stipulated period of 15 (fifteen) days from the date of receipt of this notice, it shall be presumed that you have nothing to state in your defence, and in that event the occupation/construction will be considered to be unauthorized and non-compoundable, and accordingly you will be given a reasonable opportunity to vacate the land within the next 15 days upon which necessary eviction proceedings will be initiated as per law.
