The Tender Document may be obtained from the office of the Narayanpur Municipal Board by the intending bidders on payment of Tender Paper Cost in the form of Demand Draft duly pledged to the Executive Officer, Narayanpur Municipal Board, which is non – refundable, during office hours from 10.30 a.m. to 5.00 P.M. working days from 5th September, 2025 up to 16th September, 2025.

The completed tender(s) will be received by the undersigned at his office up to 2.00 p.m. on 17th September, 2025 and will be opened on the day of 18th September, 2025 at 12.30 P.M. in the presence of the intending bidders or their authorized agents. If the office of the undersigned happens to be closed on the date of receipt of tender, the tenders will be received and opened in the same venue and time on the next working day.

Earnest money @2% of the tender amount in the form of NSC/KVP/CDR/FIXED DEPOSIT duly pledged to the Executive Officer, Narayanpur Municipal Board will have to be deposited along with each tender. In case of bidder belonging to SC, ST, OBC or an unemployed Graduate Engineer (Proof to be enclosed along with tender) the earnest money will be 50% of the value of earnest money to be deposited.

- Tenders without requisite earnest money will be summarily rejected.
- The bidder shall fill in the rates and prices offered by him (in figures) for all items of the Works described in the Bill of Quantities (BOQ) along with the total bid prices. The bidders have to quote their rate against each item up to two decimal places only.
- The Tender will not be valid without requisite Court fee stamp.
- Name & Address should be written below the signature of contractor in the prescribed tender form.
- Firm submitting the tenders should enclose a copy of registration certificate and a certificate copy of the power of attorney, authorizing any person to execute contract if any.
- All tender must be accompanied with (i) PAN Card (ii) GST registration Certificate (iii) Labour license up to date (iv) Contractor Registration certificate up to date (v) I.T. Return for last 3 years. (vi) Cast Certificate (vii) Bank Solvency Certificate (Minimum 10% of the work value) (viii) Similar nature of work having completed worth of Rs. 1/3 of contract value (x) Reports of financial standing of the bidder, such as the profit and loss statement and auditor's report for the last 3(three) years. (xi) Voter Card (xii) Form of Bid
- Here by confirm that the original documents related to this tender will be submitted at the time of opening of bid as required by the tender committee.
- The Contract must not be sublet to other parties.
- Performance deposit an amount equivalent to 2% (two Percent) of the bid value shall be made up by the contractor at the time of sign of the contract agreement within 5 (Five) days the date of issue of the acceptance letter, and rest of 8% must be deposited / adjusted at the time of payment of Bill.
- The intending tenderers or their authorized agent may remain present at the time of opening of the tenders if so desire.

- No tools & Plants will be supplied by the Department and not separate payment will be made for contractor's tools & plants.
- The Contractor will have to arrange the materials for completion of work in schedule time. The department will not liable for any loss or damage of materials stocked in the site or anywhere.
- If the selected tenderers fail to commence the work within the stipulated period, the work order and his earnest money will be forfeited.
- The security deposit will be retained by the Department for 6 months after completion of work.
- The Contractor must thoroughly acquaint himself with all terms and conditions of the contract in PWD F-2 form and agree to the conditions set down in the contract.
- Goods and service Tax (GST) as admissible will be deducted from the contractors bill as per rate included in the estimate.
- All works will be carried out as per relevant provisions of Rural Roads for all division under PWRD, Assam for the year 2020-21 and as per relevancy departmental norms guidelines.
- The name of the work must be mentioned on the Tender cover / Envelope.
- No advance Payment in any form will be paid to any Contractor.
- No Claims for interest will be entertained for delayed payment.
- The prices remain firm till completion of the work, no claim on account of price variation / escalation shall be entertained, once the rates are finalized an agreement is signed.
- Any rate submitted below more than 5% will be considered as rejected.
- The Town level Evaluation Committee reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever and does not bind itself to accept the lowest rate.

The tender must be accompanied with a self-attested copy of valid registration under APWD (Roads), GST registration, Income tax certificate, Labour license, Pan Card, Audited /Unaudited Balance sheet for the last three years along with details of the information as per the clauses in the information to the bidders in the Tender document. The bidders are requested to go through the Tender Document clearly and furnish information along with the Tender.
