- 1. Bidder has to submit separate Bid/Tender document for each group of work if he /she desire to participate in more than l (one) group of work enlisted and notified above in tabular format.
- 2. The rate are to be quoted in percentage basis above /below/as per the following schedule of rates DSR 2021.
- 3. 1% (one percent) over the work order value will be deducted for the delay of every 15 (fifteen) days if any subject to maximum 10% over the work order value.
- 4. No hand broken chips will be allowed to execute the PCC/RCC works.
- 5. The work has to be completed within the schedule time which includes all rainy days, No time extension will be allowed without any valid reason.
- 6. Tender without earnest money /court fee/incomplete tender will be summarily rejected.
- 7. Damage of any underground water supply pipeline/Telephone cable line will have to repair/restore at own cost by the contractor.
- 8. The rate should be clearly quoted in figure and in words. In case of any discrepancies, the rate quoted in words shall be treated as valid.
- No overwriting in rate will be accepted. Any correction/alteration must be signed with initials.
- 10. The undersigned reserved the right to reject any tender in full or in part without assigning any reason thereof.
- 11. The undersigned is not bound to accept the lowest tenderer.
- 12. The current registration number, and name of departmen must be quoted very Clearly.
- 13. Full name and address of the tenderer should be mentioned very clearly.
- 14. Once the tender is opened and accepted, no request to enhancement of rate will be honoured.
- 15. The contractor will be fully responsible for any loss or damage of the materials and the Value of the materials will be recovered doubled the cost of issue rate From the contractor.
- 16. The contractor at his own expense to make of any good structure damaged in the course of execution of the works. All the cost of the issue materials will be realized from the bill.
- 17. All kinds of taxes like GST, IT, FR, SBM, Labour cess etc whatever applicable will be reimburse from the bill.
- 18. The contractor have to start the work within 7 (seven) days from the date of issue of the formal Work order.
- 19. 8% security money will be deducted from the final bill and it will be refundable after Satisfactory completion of defect liability period of 1 (one) year.
- 20. The work to be completed within stipulated period. Otherwise the Dabaka MB reserves the right to Cancel the work order without making payment to the contractor.
- 21. P.W.D.Road/building/other department registration certificate of the bidder must be submitted
- 22. Upto date labour licence, Employees P.F.last Challan copy. Turn over of last three years must be submitted.
- 23. In case of bid amount below 10%, excess amount beyond 10% of the bid amount is to be deposited as performance security with proper justification for the sake of better quality of work.
- 24. Technical bid & financial bid should be submitted separately as it will be evaluated separately.
- 25. The contractor must have to submit the work done certificate/work order /Experience certificate of similar nature of work, completed in last 3(three) years issued by the authorised Engineer-in charge or concerned authority preferably of Municipal Board.
- 26. Please note that payment will be made as per availability of fund under the concern head.
