- 1. The proposer must be the lawful owner or authorized lessor of the land.
- 2. The land must be free from all encumbrances, disputes, and litigations.
- 3. The proposer must be able to provide clear title documents and land revenue receipts.
- 4. The land must comply with local zoning and land use regulations.
- 5. Location of land must be within the Municipal master plan area preferably near National High Way / State Highway.
- 6. The lease/hiring shall be initially for 10 years, extendable based on mutual consent.
- 7. Hire/lease value shall be mutually agreed upon after proper evaluation of prevailing market rates.
- 8. The land shall be used solely for the purpose of Bus Stand infrastructure and related public facilities.
- 9. The lessor must not enter into agreement of any type with any other third party agency/ individuals except Municipal Board duly represented by Executive Officer and permit necessary modifications, constructions, and installations by the Municipal Board authority.
 - 10. Interested parties are to submit their proposals in sealed envelopes clearly marked "Proposal for Hire/lease of Land for Bus Stand Dabaka Municipal Area", containing the following
 - (i) Cover Letter expressing interest.
 - (ii) Details of the proposer Name, Address, Contact Number, PAN, etc.
 - (iii) Land details Location, area, plot number, boundaries, and current land use.
 - (iv) Ownership documents Patta, Jamabandi, Land Revenue Receipt, NOC if applicable.
 - (v) Proposed lease terms Expected rent, period, and other conditions.
 - (vi) Location map and photographs of the land.
- 11. The Municipal Board shall evaluate all received proposals based on location suitability, accessibility, land size, and proposed rent. Shortlisted proposers may be called for site verification and negotiation. The decision of the Dabaka Municipal Board shall be final and binding.
